Why employ apprentices?

Apprenticeships are an exciting option for both apprentice and employer.

You can employ apprentices at different levels, from school leavers and university graduates, to people who want to further their careers or change career direction completely - you can hire someone new or upskill an existing employee. Grow talent and develop a motivated, skilled and qualified workforce that will deliver direct, positive results into your organisation.

Funding an apprenticeship

Employing an apprentice is simple and straightforward. You can access government funding or use your apprenticeship levy funds to train new apprentices or existing employees.

- The amount of government funding you get depends on whether you pay the apprenticeship levy or not.
- You pay the levy if you're an employer with a pay bill over £3 million each year.

Using your apprenticeship levy

- The government will apply a 10% top up to the funds you have in your account.
- If you don't have enough funds, you just pay 5% of the outstanding balance and the government will pay the rest.
- If you do not pay the apprenticeship levy, you pay just 5% towards the total cost of training an apprentice and the government will pay the rest.

The benefits

- **Dedicated support** from a programme manager to support your apprentices throughout.
- **Location** All training and one-to-ones will take place at a convenient location or virtually, no matter where you are.
- **Funding** Costs are supported by the apprenticeship levy/government funding.
- **Study materials and resources** such as books and eLearning to accompany each module.
- **Complete package** includes workshops, revision sessions, exam fees, tutor one-to-ones and EPA mentoring.

How and where?

We'll run programmes for up to 16 apprentices at a time, either from a single organisation or from more than one. If the whole group is from a single organisation, training and one-to-ones will take place on site; otherwise it will be arranged in consultation with the various parties.

Apprentices must be aged over 18, have GCSEs in Maths and English at grade C or above, and not have studied procurement at Level 4 before.
