Job Summary

Responsible and accountable for the development of assessments, and associated marking schemes where required, which are fit for purpose and adhere to CIPS assessment specification, guidance and timescales, ultimately ensuring that the standard and integrity of CIPS assessments is recognised globally.

Authors are required to have a very high standard of written English, with an understanding of language accessibility to avoid the unintentional use of irrelevant features in developing assessment items.

Key Responsibilities

CIPS Assessment authors are responsible and accountable for:

Writing assessment items, and associated marking schemes where required, that are fit for purpose. Questions must be:

- To specification: Reflect the assessment specification, qualification level and associated level descriptors
- Valid: Reflects the module content, learning objectives and assessment criteria
- Accurate: Are accurate, grammatically correct, free from error and free from ambiguity
- Accessible: Must not discriminate against any group of candidates, must be free from colloquialisms or unnecessary barriers for learners
- Timely: Ensuring items are submitted to CIPS on time using the CIPS assessment platform
- o Secure: Ensuring the security and confidentiality of all assessments is maintained

Authors will be required to maintain continuing professional development (CPD), at their own expense, in the context of CIPS chartered professional status (or equivalent with prior agreement of the Assessment Development Manager).
