### The best possible place

Having already created the structure and momentum for change, the procurement function found itself in the best possible place to respond to each crisis as it unfolded, while also continuing its development journey. By the end of 2022, a mapping exercise revealed that 25% of its operational practices had changed.

This was also the moment for Laing O'Rourke's next Procurement Excellence Programme reassessment, giving it a timely opportunity to discover how these changes stacked up against the highest standards worldwide.



### Ready for everything

The process of evidence gathering and evaluation across every aspect of procurement brought out that Laing O'Rourke had developed some highly effective mechanisms to deal with today's market challenges.

The CIPS Assessor highlighted its de-risking of projects through the identification of supply chain risks up front and a pre-tender approach to market analysis and vendor profiling. It also found the procurement data portal to provide exceptional visibility of every part of the function plus pertinent external financial and market data for decision making, planning, control and cost saving. A new career toolkit linking Laing O'Rourke's capability and behaviour requirements with the CIPS Global Standard was also highly rated.

According to Laing O'Rourke, the Procurement Excellence Programme assessment and award enable the procurement function to:

- Demonstrate it has sound procurement policies, strategies, procedures and processes which have been independently verified
- Provide internal and external stakeholders with assurance that the function is operating effectively, diligently and in compliance with the requirements of its day-to-day procurement activities
- Identify opportunities for creating better ways of working leading to efficiency savings

- Demonstrate that it operates within a robust ethical framework
- Build reputation and credibility within the marketplace with stakeholders including investors, vendors, clients and competitors
- Provide a development opportunity for the team showing what good procurement practice looks like
- Have a positive effect on the morale of its people through engagement, empowerment and evolution of how the 110-strong team performs
- Increase visibility of the value team members bring to the company.



## **Working in sync**

For Laing O'Rourke, its successful Procurement Excellence Programme reassessment confirmed the commercial value of its mission-driven focus on risk and understanding the impact on its work of what's going on in the supply chain and wider world.

The award also meant it knew for sure that every element of procurement, from strategy to systems and people to processes, is working in sync in terms of focus and level of performance. This in turn boosted the function's profile internally, showing it is raising the level of suppliers throughout the business and that the company's strategic goals can be met through its supply chains.

As the assessment framework is regularly revised, the company could be confident that procurement had been benchmarked against slightly different factors second time around, proving it is keeping abreast of contemporary issues, concepts and solutions.
