These **five dimensions** are common to every business, no matter what sector or market; they are essential facets of how an organisation operates. The ESG golden thread is woven throughout each dimension to ensure it becomes an intregal part of how an organisation operates and adheres to to the United Nations Sustainable Development Goals. Each award is valid for two years, after which you can either increase or maintain your level of award to ensure that you continue to operate effectively, delivering value in the face of changes in your organisation and the marketplace.
